- 1. In case of any inadvertent mistake in the process of selection which may be detected at any stage, even after the issue of appointment letter, the Institute reserves right to modify/withdraw/cancel any communication made to the candidates.
- 2. No TA/DA will be provided to candidates for appearing for the Written Test/Presentation/Interview/Document verification in case it is held offline/online.
- 3. IIIT Ranchi has reserved the right to accept or reject any application without assigning any reason thereof.
- 4. In case of any dispute/ambiguity that may occur in the process of selection the decision of the IIIT Ranchi shall be final.
- 5. The written test/ screening test will be of 60 -120 minutes duration with Multiple Choice Questions (MCQ) with negative marking for wrong answers that will be specified on the Question-Sheet.
- 6. Candidates will be shortlisted for next stage on the basis of written test. If number of candidates appear in the date and time of interview is less than 10 (ten) in number, the written test will be waived off.
- 7. Name of the shortlisted candidates will be displayed on the website & notice board of the Institute.
- 8. Only shortlisted (through written test) candidates are required to deliver a presentation on any topic related to B. Tech (CSE) programme before the group of students and faculty/ experts. Presentation be restricted within 10 minutes. Maximum 10 numbers of PPT slides be used for presentation if required.
  - If number of candidates appear in the date and time of interview is less than 10 (ten) in number, the written test will be waived off. But candidates are required to give presentation.

- 9. Only shortlisted (through presentation) candidates are required to appear before Expert panel.
- 10. Candidates must bring the following documents in original to be checked before the interview.
  - (i) All certificate(s), marks sheets and testimonials in original.
  - (ii) A certificate from your present employer (if applicable) indicating your designation, nature of appointment (permanent/temporary/ad-hoc) and scale of pay along with last pay certificate (basic & other allowances).
  - (iii) All original certificates in support of your claim of experience and all other details specified by you in your application.
  - (iv) An original caste certificate issued by the specified/competent authority in case of SC/ST/OBC/EWS & Person with Disabilities. Please ensure that if above certificates are issued in other than English or Hindi Language, a translated copy in English/ Hindi duly attested by the gazetted officer is must. In absence of above, the candidate will not be considered against reserved posts. Further, OBC/EWS applicants are also requested to produce a certificate issued after 01.04.2022 at the time of documents verification indicating that he/she does not belong to any of the creamy layer issued by the specified authority.
  - (v) The marks obtained in the written test will not be considered for preparation of the merit list for the selection of the candidates. As per policy, a few numbers of candidates will be screened out on the basis of performance in the written test and presentation for interview. Documents verification will be done only for those who qualified the written tests.
  - (vi) Applicant(s) employed in the Govt/Quasi Govt./PSUs whose application has not been forwarded through present employer must bring NO OBJECTION CERTIFICATE (NOC). Without NOC he may not be allowed to appear before the interview board.
