Result Declaration Policy for Spring Semester 2019-20 in COVID-19 Pandemic Situation.

The Senate in its 2nd meeting (by circulation) held on 26th June 2020 decided to declare the spring semester teaching program closed with effect from 31st May 2020.

- Evaluation and finalization of the result of final year B. Tech (Hons) was done on the basis of online presentation and viva-voce of internship (16 Credits) and Project Seminar (2 Credits).
- Evaluation and declaration of the result of the regular B. Tech (Hons) batches of 1st, 2nd, 3rd year was done on the basis of online mid semester examination (30%), continuous assessment by faculty member (20%) and performance in the immediately preceding semester (50%).
- Evaluation and declaration of the result of the B. Tech (Hons) batches of 1st, 2nd, 3rd year with backlog in previous semester was done on the basis of online mid semester examination (30%), continuous assessment by faculty member (20%) and performance in the immediate preceding semester (50%). The present semester marks will be unchanged even student improves his/her marks in specific subject by clearing backlog examination of previous semester.
- Evaluation and declaration of B. Tech (Hons) batches of 1st, 2nd, 3rd years with result upheld due to unfair means in previous semester was done after the clearance of the last autumn semester.
- Evaluation of laboratory courses of B. Tech (Hons) batches of 1st, 2nd, 3rd years was done on the basis, of assessment of student's laboratory work prior to lockdown and their performance based on online vice-voce examination.

Tech (Hons.) programme in CSE and ECE departments should be increased to at least 220 seats, where present admission strength is 150. In such circumstances, total number of students should be divided into sections for the smooth functioning of the classes and to ensure the quality education for each and every student. As per NEP-2020, science and humanity subject are to be included in curriculum for B. Tech and M.Tech. programs.

(i) Regular and Contractual (more than one year) employees:

- a) Maximum premium of Rs 20,000 per employee per year will be paid to the employee on production of copy of insurance policy where in employee's name will be mentioned as one of the policy holders. The concerned employee can include dependents from his/her family. Even employee can raise the premium amount as per his/her desire, but institute will pay up to the maximum limit of Rs. 20,000/-.
- For OPD reimbursement on actuals as per CGHS rates on production of prescription from registered medical practitioner and voucher of purchased medicines.

(ii) Temporary/contractual employees (less than one year):

- a) Maximum premium of Rs 10,000/- per employee per year will be paid to the employee on production of copy of insurance policy where in employee's name will be mentioned as one of the policy holders. The concerned employee can include dependents from his/her family. Even employee can raise the premium amount as per his/her desire, but institute will pay upto the maximum limit of Rs. 10,000/-.
- For OPD reimbursement on actuals as per CGHS rates on production of prescription from registered medical practitioner and voucher of purchased medicine.
- (iii) The above-mentioned medical facilities may be approved post facto for regular and contractual employees (more than one year).

Comments from Ministry: Being the financial matter, this should be placed in BoG only after consideration of the same by Finance Committee. The Institute is in PPP mode where the Institute is not going to get any recurring assistance beyond a certain limit from anywhere. The Institute has to be self-sufficient own its own out of their IRG. Hence, rather than putting any money from Institute side, the Institute can provide a common platform to facilitate employees for group insurance and that should be self-contributed.
