Instructions to the Candidates

1. In case of any inadvertent mistake in the process of selection which may be detected at any stage, even after the issue of appointment letter, the Institute reserves right to modify/withdraw/cancel any communication made to the candidates.
2. No TA/DA will be provided to candidates for appearing for the Written Test/Interview/Document verification in case it is held offline/online.
3. IIIT Ranchi has reserved the right to accept or reject any application without assigning any reason thereof.
4. In case of any dispute/ambiguity that may occur in the process of selection the decision of the IIIT Ranchi shall be final.
5. The written test/ screening test will be of 60 -120 minutes duration with Multiple Choice Questions (MCQ) with negative marking for wrong answers that will be specified on the Question-Sheet.
6. Candidates will be shortlisted for next stage on the basis of written test.
7. Name of the shortlisted candidates will be displayed on the website & notice board of the Institute on 29.04.2022
8. Only shortlisted (through written test) candidates are required to appear before Expert panel on 30.04.2022 from 02:00 noon onwards. Interaction will consist of 5 minutes presentation highlighting research work and 5-10 minutes of oral interaction with experts.
9. Candidates must bring the following documents in original to be checked before the interview.
 - (i) All certificate(s), marks sheets and testimonials in original.
 - (ii) A certificate from your present employer (if applicable) indicating your designation, nature of appointment (permanent/temporary/ad-hoc) and scale of pay along with last pay certificate (basic & other allowances).
 - (iii) All original certificates in support of your claim of experience and all other details specified by you in your application.
 - (iv) Applicants seeking reservation benefits available for SC and ST must be in possession of the certificates in the formats prescribed by the Government of India. Also, applicants seeking reservation benefits available for OBC-NCL and EWS must be in possession of the certificates in the format prescribed by the Government of India (**Current Financial year Only**) in support of their claim at the time of application.
 - (v) An original caste certificate issued by the specified/competent authority in case of SC/ST/OBC/EWS & Person with Disabilities. Please ensure that if above certificates are issued in other than English or Hindi Language, a translated copy in English/ Hindi duly attested by the gazetted officer is must. In absence of above, the candidate will not be considered against reserved posts. Further, OBC/EWS applicants are also requested to produce a certificate issued after 01.04.2022 at the time of documents verification indicating that he/she does not belong to any of the creamy layer issued by the specified authority.
